Chautauqua County Solid Waste Policy

Chautauqua County Solid Waste provides curbside and rural pickup for customers. Rural dumpsters are available for customers that we don't supply curbside service too. Rural dumpsters located in Sedan and Cedar Vale. Rural dumpsters are to be used for paying rural customers only. Rural dumpsters at this moment cost \$18 per month, residential and rural pickup cost \$20 per month. Commercial cost varies depending on volume. This could possibly rise due to rise in expenses.

Deposit is required \$60.00 upon starting service for residential. Deposit for rural customers is \$54.00. Deposit is for new customers or past customers with a delinquent history. Past customers with good payment history, deposit isn't required. Deposits will be refunded to the customer when the account is current and closed.

Trash service is required for any resident on city utility or within city limits of Chautauqua County. Cities include are Sedan, Cedar Vale, Elgin, Chautauqua, Peru, and Niotaze.

Poly-carts are available for purchase. Call for pricing.

Sedan- Monday-Friday

Cedar Vale- Monday & Thursday

Peru/Niotaze-Tuesday

CQ/Elgin- Wednesday

Business-Friday

Rural Dumpsters - Daily and weekends.

Dump daily at the landfill

NO dumping at any time at the rural dumpsters if caught will result in prosecution.

WE DO NOT HAUL ITEMS LISTED BELOW

- -No yard waste (brush, yard trimmings, leaves, dirt)
- -No construction material (scrap wood, shingles, bricks, plaster)
- -No iron or metal (pipes/rods/tin)
- No white goods (washers, dryers, hot water heaters, stoves, refrigerators)

- -No liquids (oil, paints, cleaners)
- -No tires
- -No vehicle batteries

If you have these items, you may call our office for options for the proper disposal.

Please bag all trash in cans and don't fill cans over 50#'s.

Only Holiday we don't run is Christmas at this time we try to enjoy family time.

Due to weather in the winter, if it's putting our employee's safety at risk, we will not be running. Trash pick-up will run a day behind.

Billing is sent out first of the month due by the 25th of each month or late charge will be assessed. Billing is a month behind so Jan 1-Jan 31st is due by Feb 25th. **Late charge will be \$2.00.**

Accounts past 90 days delinquent will result in a <u>no pick-up</u>, there will be a \$60 deposit required to reestablish pickup, plus payment of the delinquent amount.

End of July each year, delinquent accounts are sent to the state for collection, collection agency, and/or added to property taxes if the account is in the land owner's name.

We accept cash, check, debit/credit cards. All debit/credit cards have a fee to process. You may also get with your bank and set up automatic withdraw. At this time online bill pay is only available through walk in or over the phone.
