October 25, 2016

Chairman Goff Searl called the meeting of the Chautauqua County Board of Commissioners to order on Tuesday, October 25, 2016 at 8:30 a.m. in the commission room of the courthouse. Commissioner Jack Carpenter and Danny Williams were present as was County Counselor Ruth Ritthaler and County Clerk Janice A. Fine. Danny Williams opened the meeting with prayer.

Minute's approval: Danny Williams made a motion to approve the minutes of October 18, 2016 as presented. Jack Carpenter seconded the motion. Motion carried 3-0.

Joel Haden, Road & Bridge Superintendent gave his weekly report. Crews are hauling rock to the following: Frontier and Rd 13, Eagle and Rd 4 south of Cedar Vale, De Bush Cemetery, Bronco and Rd 28, and in the Southeast district. The Cook Bridge corners have been welded. Brush was removed at the Walt Moore crossing. A right of way was cleared at Street I and Hwy 166 in Niotaze. Haden stated KCAMP approved use of the yearly grant to purchase delineators. Haden discussed the stop signs that a grant is being applied for through our engineers for on system roads. Commissioners requested Haden to review specific road issues.
