Chairman Jack Carpenter called the regular meeting to order on Monday, July 3, 2017, at 8:30 a.m. in the commission room of the Court House. Commissioner Goff Searl, Commissioner Rodney Shaw, County Clerk Niki Collier and County Counselor Ruth Ritthaler were all present. Commissioner Goff Searl opened the meeting with prayer.

Steve Steinbach joined the discussion and stated this has been a problem for several years and he feels the road is being overworked and that is causing the water to runoff and damage his fence. He request the Commissioners to come and observe the road.

Joel stated he talked to his employee regarding the citizens concern and the employee denied fishing during his work day. He stated that he does eat lunch on the pier and he does fish there in his personal white truck that also has tools in the back. Joel said he believed the employee.

Commissioner Carpenter stated that Linda Kline, asked the Commissioners to consider adding a magnet to the road grader in an effort to pick up objects that lead to tire damage. Joel will look obtain information and pricing and report back to the commissioners.
