## April 11, 2013

The Chautauqua County Board of Commissioners sat as the Board of Canvassers on Thursday, April 11, 2013 at 8:30 a.m. in the commission room of the courthouse. Commissioners Jack Carpenter, Goff Searl and Danny Williams served as canvassers. County Clerk Janice A. Fine and Election Assistant Crystal Wade were also present. Danny Williams gave prayer.

County Clerk Janice A. Fine presented the preliminary tally from the April 2, 2013 City/ School/Extension General Election. There were 673 total ballots cast which equates to a voter turnout of 29%.

Several individuals who received votes declined the position prior to the canvass so the Board of Canvassers drew names for the last two positions based on the next group of votes received.

The County Clerk presented 10 provisional ballots for consideration. After reviewing the circumstances of each ballot, the Board of Canvassers approved 8 of the provisional ballots and disallowed 2 of the provisional ballots. As a result of the provisional canvass there were 671 certified ballots.
